

Privacy Policy

Premier Team International Inc. ("PTI"), is committed to protecting the privacy and security of individuals who visit any PTI website(s) (the "Site"). The purpose of this Privacy Policy is to inform you as to what information may be collected from you when visiting the Site, how such information will be used by PTI, PTI Member(s) (the "Member"), and/or other persons or entities, with whom such information may be shared. Its purpose is to also inform you of your choices regarding the collection, use, and distribution of such information, your ability to delete such information, and the security procedures PTI has implemented to protect your privacy.

Collection of Personal Information: The primary goal of PTI in collecting personal information from you is to assist the Member in providing you with the products and information that you request from the Member. Personal information also allows PTI to provide the information, services and products that you have requested from the Member. Personal information received from you online will only be used by the Member to which you submitted your information, except as where PTI is otherwise required by law to disclose such information. When you visit the Site, PTI and the Member will not collect any personal information about you (including but not limited to your name, address, telephone number, email address, and credit card number if you place an order) unless you provide it voluntarily. If you do not want to disclose your personal information, please do not submit it.

How Personal Information is used: The Member may use your personal information to contact you. For example, the Member may send you marketing or promotional materials including emails or other information; may respond to your comments or requests for information; or may contact you if needed in the course of processing or shipping your order for products or services offered through the Site. The Member may enhance or merge personal information with data obtained from third parties for the same purposes. The Member may use your personal information to improve their marketing and promotional efforts, to statistically analyze site usage, and to improve their content and product offerings. The Member may use your personal information to deliver information to you that, in some cases, is targeted to your interests, such as new services and promotions. The Member may also elect to occasionally send visitors who have opted-in, emails describing new products, promotions, or events. These services are optional and you may opt-out of these services completely, at any time by clicking the opt-out link of any given promotion. PTI will only store your personal information for a reasonable period of time.

Collection of Aggregate and Statistical Data: PTI may collect certain aggregate data called web log information (such as your web browser, operating system, pages visited, etc.) and use cookies when you visit certain web pages. For instance, when you visit the Site, our web server will automatically recognize some non-personal information, including but not limited to the date and time you visited the Site, the pages you visited, the referrer (the website you came from), the type of browser you are using (e.g. Netscape, Internet Explorer), the type of operating system you are using (e.g. Windows 2000, Windows XP, etc.), and the domain name and address of your Internet Service Provider. The cookies and web log information do not obtain personal information such as your name or email address. In some cases the Member may collect information about you that you voluntarily submit which is non-personal, such as general statistical information like age, gender, occupation, languages spoken, preferences, interests, how you found the site, etc.

How Aggregate and Statistical Data is used: PTI uses web log information (such as your web browser, operating system, pages visited, etc.) to help design the Site, to identify popular features, and for other managerial purposes. However, web logs may be used if necessary to help identify any person attempting to break into or damage the Site, or use the Site to commit any illegal act. PTI may share web log information with law enforcement agencies if evidence arises of a violation of computer security or related laws. Statistical Data is used to help the Member in their marketing and promotional efforts.

Data Sharing: PTI and the Member will not share, trade, rent, or sell the personal information of our visitors for use by any business without your consent. However, aggregate and statistical data from our visitors may be shared with our partners. PTI and the Member will share the information necessary to deliver products and services that you specifically request to receive but will limit this information to only what is necessary and required to complete a transaction. Occasionally, PTI and the Member may share personal information from you (such as name, mailing addresses and email addresses) with vendors, contractors or partners of PTI in connection with services that these individuals or entities perform for/with PTI. These vendors, contractors or partners are restricted from using this data in any way other than to provide services for PTI and the Member, and they may not share, trade, rent or sell this data. PTI also reserves the right to share the information to respond to duly authorized information requests of governmental authorities or where required by law.

Data Security and Responsibility: PTI is committed to keeping the data you provide us secure and will take reasonable precautions to protect your personal information from loss, misuse or alteration. Vendors, contractors, or partners of PTI who have access to your personal information in connection with providing services for PTI are required to keep the information confidential and are not permitted to use this information for any other purpose than to carry out the services they are performing for PTI. PTI uses secure connections on the Site to protect credit card information during its transmission. PTI shall not be responsible for harm that you or any person may suffer as a result of a breach of confidentiality in respect to your use of the Site or any information you transmit to the Site.

Cookies: When you view the Site or interactive advertisements, PTI may collect some non-personal information about you. The collection of this non-personal information is done through "cookie" technology. Neither cookies nor web beacons nor web log information collects any personal information. When you view the Site, PTI may store some information on your computer. This information will be in the form of a small text file, also called a "cookie". Cookies help in many ways to make your visit to the Site more secure and meaningful to you. For example, cookies avoid you having to log in every time you come back to the Site. They also allow PTI to provide for the security of your session. Most browsers can be configured not to accept cookies or to indicate when a cookie is being sent. Our website requires that you accept cookies to order any products or information where personal information is being transmitted to ensure the security of the information in transit.

Third-Party Links: The Site may contain links to websites operated and maintained by third parties over which we have absolutely no control. Any information you provide to third party websites will be governed under the terms of each websites' privacy policy and we encourage you to investigate and ask questions before disclosing any information to the operators of third party websites. PTI has no responsibility or liability whatsoever for the content, actions or policies of third party websites. The inclusion of third party websites on the Site in no way constitutes an endorsement of such websites' content, actions or policies.

Protection of Children: The Site is a general audience Site that is not specifically designed or targeted at children. We do not knowingly collect, use or disseminate any personally identifiable information from children. PTI believes that it's especially important to protect children's privacy online and encourages parents and guardians to spend time online with their children to participate and monitor their Internet activity.

Modifications to Policy: This Privacy Policy is effective as of June 27, 2005. PTI reserves the right to change this Privacy Policy at any time. Any changes to this Agreement will be effective immediately upon notice, which may be provided to you by posting the latest version on the Site (hereinafter, "Notice"). Your use of the Site after such Notice will be deemed acceptance of such changes. Be sure to review this Privacy Policy periodically to ensure familiarity with its most current version. You can easily confirm whether any revisions have been posted since your last visit by checking the date on which the Policy was last revised, which is set forth at the bottom of this Policy. If you object to such changes, we will honor our prior Privacy Policies as to any data previously collected. If you disagree with the changes in our Policy, however, please do not use the Site after the posting of such changes online. By using the Site following the posting of changes to this Privacy Policy, you agree to all such changes.

Choice: PTI clearly informs you and explains how personal and aggregate information is to be used. You have a right not to provide this information. If you choose not to provide such information, you are still welcome to visit the Site, but may be unable to participate in certain options, offers, services, and promotions.
